127 REPORTS

- 127.1 <u>HCCllr Jackie Porter</u> did not attend the meeting but provided a written report (Appendix 1) which noted the following:
 - The County Council have received £7m from the Department for Work and Pensions to distribute over the winter for food, fuel and utility/heating costs. 50% is for families and the remainder for other vulnerable households. Referrals can be made through Citizens Advice.
 - The impact of the pandemic on children's learning and mental health.
- 127.2 <u>DCllr Stephen Godfrey</u> noted that there has been no update as yet from the Government on Local Authority funding. This is now expected next week.

Two major schemes in Winchester are moving forward. Designs for the central Winchester regeneration are on a smaller scale than previously envisaged and a development partner is being sought to take the project forward. It is the City Council's intention to sell the old River Park site to the University of Southampton, subject to planning permission being granted, for an extension to the School of Arts with accommodation blocks, exhibition centre etc. The skatepark will have to be retained and a consultation will be held on the future of the indoor bowling facility. Concerns have been raised that only one prospective purchaser appears to being considered for the site.

Despite assurances given to the City Councillors, no update on Carousel Park has been provided to them in time for this meeting. No responses have been received to the Planning Contravention Notices (PCN's) and legal advisors are now reviewing the next steps. New ariel photographs have been taken of the site.

130.3 119.3 <u>Affordable Housing & Exception Sites</u> The planning application for the revised parking scheme at Southbrook Cottages is awaited.

An update on the wetland project consultation will be requested.

- 130.4 119.4 <u>Village Design Statement</u> A further review of the VDS has been undertaken by Jill Lee (WCC Principal Planning Officer) and she has raised two points. The first relates to an incongruity between one of the design principles and the photograph which accompanies it. It was **agreed** that the photograph was illustrative of many properties in the Parish and that it is the design principle which requires a slight amendment. The second point raised is whether we wish to identify specific views across the countryside that should be maintained. This has been discussed previously, when it was considered that specific views should not be identified as this may give the impression that others were less worthy of being maintained. The Clerk will contact Jill with these agreed responses.
- 130.5 119.5 Winchester Local Plan & Call For Sites The Clerk attended the virtual WCC Local Councils Update on 25th November and noted the update provided on the Local Plan. In respect of the proposed development strategy, it was advised that there was little support for approach 3 (a new settlement) whilst a modified version of approach 1, with limited increases to targets for 'Winchester Town' and 'Market Towns and Rural Area' plus three additional settlements South Wonston, Otterbourne and Sutton Scotney was well supported.
- 130.6 119.6 <u>Carousel Park</u> See 127.2 above. It was noted that a serious incident took place at Carousel Park at the beginning of November.
- 130.7 119.7 <u>Community Greening Campaign</u> A public meeting, to launch the campaign, is to be held at the school at 6pm on Tuesday 14th December.

131 PARISH SERVICES

- 131.1 120.1 <u>Highways Matters</u> Cllr Bramley met with HCCllr Porter, at The Crease in Micheldever, and discussed the continuation of double yellow lines to where the road widens at the start of the church wall. The ROW information board at the LRPF has been damaged and is being repaired by the Alresford Men's Shed.
- 131.2 120.2 <u>Pavement Micheldever Station to railway bridge</u> No further update has been received from HCC on the feasibility studies being undertaken.
- 131.3 120.3 Network Rail The vegetation has still not been cleared from the height signage at the bridge on Sloe Lane. Cllr Bramley will visit and take photographs to send to Network Rail.
- 131.4 120.4 <u>SLR & Community Funded Initiatives</u> Permission has been given by the Estate for the gateway which will encroach upon their land. However, they have now raised a question about the position of the southern gate.

On 15th November, site meetings were held in Micheldever and East Stratton to review potential sites for a Speed Indication Device (SID). Suitable sites were identified in both villages, although some of those in Micheldever would require sockets at an additional cost.

It is hoped that it might be possible to achieve match funding through the WCC Crowdfunding scheme. Fundraising for a device has already been started in East Stratton, through the Northbrook Arms and the Clerk will check with WCC whether this can be brought within the crowdfunding scheme.

The Clerk will ask the HCC Safer Roads Team about the next steps in obtaining a licence to use a SID device.
